# MAHONING TOWNSHIP BOARD OF SUPERVISORS MEETING MINUTES April 12, 2023

#### **CALL TO ORDER:**

Robert Slaw called the meeting to order at 6:00PM at the Mahoning Township Building 2685 Mahoning Drive East, Lehighton, PA 18235.

#### **PUBLIC COMMENT:**

Tim Eckhart is looking for guidance on zoning questions on Nis Hollow lot as to whether it is a corner lot or not, it is on a curve with no two streets intersecting the curve which according to the definition in the zoning book, it is not a corner lot. Definition of a "corner lot" will dictate setbacks that might prohibit the sale of this property. Per Stephen, zoning officer, anything along the road frontage is a front yard which will give you two side yards and two front yards, no back yard. Stephen is ok with assigning this property as a corner lot and setbacks would apply as such.

Recommended that Tim and Stephen meet at the property with a property design that best describes what the potential owner wants to do. Natalie will contact Stephen in the morning to meet with Tim.

Jake Ahner is asking on behalf of The Flagstaff whether residential lots can be used to park cars if there is overflow parking. The potential need for overflow parking is in relation to the tram service to JT. Advised to discuss with the zoning officer.

Donna Crumb, President, and founder of Blue Mountain Animal Rescue Society approached the board for permission and guidance to host their annual Rock n Rescue, a 3-day, family oriented, event in Mahoning Township. Mahoning Township resident, Matt Boyer, offered his property (located across the street from Tractor Supply) to house the event. The event will take place July 7-9, 2023, and will include 80's night DJ, cornhole tournament, rabies clinic, car show and nonprofit events. There will be (5) live bands (1pm-9pm) and food vendors and beer garden. Donna does not expect parking to be an issue because there is over 2 acres.
